



Athlete Code of Conduct

As a participating athlete in the CSM Club Sport Program, I agree to abide by the following:

- I will conduct myself accordingly, responsibly, and professionally, at any and all Club Sport sponsored activities. These include home and away matches, as well as any extracurricular activities.
- I understand that my actions may adversely affect my team, the Club Sport Program, the Department of Recreational Sports and Colorado School of Mines.
- I will represent CSM, the Division of Student Affairs, the Department of Recreational Sports and my team in a professional, positive manner.
- I will show respect to all competition officials, opposing team members, spectators and Department of Recreational Sports employees.
- I will adhere to all CSM Recreational Sports policies and procedures. These include; the Club Sport Handbook, SRC Facility policies and procedures, and all other university policies and procedures, including the Code of Student Conduct.
- In accordance with CSM Alcohol and Hazing policies, I recognize that the Department of Recreational Sports and the Club Sport Program observe a NO TOLERANCE RULE. I also understand that failure to comply will adversely affect my team and myself.
- I understand that my actions may adversely affect my ability to participate in any of the aforementioned programs and/or remain as a functioning entity of Colorado School of Mines' Sport Club Program.

I understand that if I do not adhere to the above guidelines than the following consequences may occur. I also understand that the following consequences are not progressive, meaning that one does not have to precede the other. The severity of the offense will determine whether other entities become involved. I understand that Recreational Sports reserves the right to inform campus officials of infractions, and that those decisions are independent of any decisions made by Recreational Sports and the Club Sport Program.

Individual Violations

- Probation and placement on contract by the Director of Intramural & Club Sports.
- Community Service hours assigned by the Director of Intramural & Club Sports.
- Suspension from sport club activity for duration of time based upon severity of offense.
- Removal from the Club Sport Program.
- Referral to Student Judicial Affairs for university disciplinary action.

Team Violations

- Probation and placement on contract by the Director of Intramural & Club Sports.
- Community Service hours assigned by the Director of Intramural & Club Sports.
- Forfeiture of a number of competitions based on the severity of the offense.
- Forfeiture of activities, privileges or services provided to team (including competitions, facilities, and finances)
- Suspension of team from the Club Sport Program.
